### Introduction

The Interreg South Baltic Programme's area is unique, as it covers five Member States regions mostly without land borders – the borders between them are on the Baltic Sea.

The central location of the sea affects transportation patterns and socio-economic convergence processes in the South Baltic Area (SBA), the maritime character of historical trade relations, the joint asset of extensive and relatively undisturbed natural areas, and shared importance of economic sectors, utilising rich natural resources (both land and sea-related), determine the role of the blue and green economy for sustainable and innovative regional growth in the SBA.

- interdepartmental processes (e.g. maritime sector, logistics in passenger and freight transport
- learning methods, e.g. web tools, applications
- Collaborative actions:
- establishing a collaboration platform for digital innovation centres/universities/R&D institutions and SMEs to support the SBA modernisation and digitisation
- promoting the digitisation process and new digital solutions
- strengthening the digital society, including the development of electronic services for the elderly and/or disabled
- Supporting the development of digital capabilities for employees in the public sector for modern administration and the implementation of public policies
- Transferring knowledge on technical standards and the exchange of best practice between regions

- cross-sectoral networks/clusters and their expansion which aim at improving the innovation capacity and quality of services and internationalisation
- organisation of activities: fairs, exhibitions, marketing and joint branding campaigns, promoting products and services from the SBA in international markets.

- use of green energy and support establishing new markets
- elaboration of
- green policy strategies and patterns to overcome challenges and mobilise regional opportunities for renewable energies
- common cross-border standards in renewable energy used by public entities, in cooperation with universities, research centres, companies and cooperatives of farmers and residents
- capacity building actions, transfer of knowledge and exchange of best practices on green energy and green technology solutions

- decreasing the outflows of nutrients from small and diffuse sources in the catchment areas
- sustainable water management aimed at enhancing nature protection and biodiversity
- securing conflicting water uses that serve public interests, as well as future water supply
- reducing pollution of the Baltic Sea by chemical munitions and other dangerous remains of sunken oil ships
- promoting areas of cooperation for:
- the enhancement of the aqua-culture
- the water management policies, e.g. joint strategy development, joint cross-border studies, action plans
- elaboration and testing of common cross-border standards in waste and water management by public entities/ universities/R&D centres/companies/cooperatives of farmers and residents,
- capacity building actions, transfer of knowledge and exchange of best practices in fields of water management and wastewater collection and treatment

# 2.3 SUPPORTING A CIRCULAR AND MORE RESOURCE EFFICIENT DEVELOPMENT

#### What can you do?

- developing and implementing:
- new business models, product designs (prevent waste, use non-toxic materials to prepare for reuse and recycling), production and distribution technologies/solutions/processes in waste/water management and resource efficiency, including the optimised energy utilisation and industrial symbiosis
- solutions/investments that minimise the use of new raw materials, including the promotion of recycled materials
- cross-border cooperation networks aimed at the re-use of waste as a resource
- optimisation of value chains for recycled materials, forest and agricultural bio-products
- pilot projects aimed at building awareness among inhabitants about the necessity of waste management systems in households
- promoting the waste management policies: joint strategy development/joint cross-border studies/action plans
- •cross-border promotional and awareness-raising campaigns aimed at local public companies and SMEs to facilitate the transition from traditional management to circular oriented
- elaboration and testing of common cross-border standards in the waste management by public entities, in cooperation with universities, R&D centres, companies and cooperatives of farmers and residents and NGOs,
- capacity building actions, transfer of knowledge and exchange of best practices on the waste management solutions

- new tourist offers/small cross-border solutions that enhance sustainable tourism and meet the needs of tourists/citizens of the region (e.g. cross-border thematic routes)
- preservation of cultural heritage in the SBA: culinary heritage/history/language
- marketing and promotion of cultural and natural assets/cultural heritage routes/ecotourism/ handcrafts/design
- actions to protect the biodiversity and natural heritage of the SBA, including natural heritage sites and protected areas
- adapting tourist's offer to people with disabilities and activities aimed at social inclusion
- sharing knowledge and best practices in the field of maintenance and revitalisation of cultural/natural heritage areas and establishing networks
